In order to secure a booking a payment of £150/week is required immediately.

10% should be deducted from the rate for second and third weeks of booking.

If confirmed booking is made before 31 January please deduct a further 10% from the total.

The balance of the total amount is to be paid 8 weeks prior to the start date of the rental. If booking within 8 weeks of your holiday, full payment is due with booking.
